AIC Foundation Selects "The Dirty Dozen"

The following is a list of the "Dirty Dozen" corporations. These are firms that are particularly flagrant in encouraging mass immigration (legal or illegal) despite its impact on our country's cohesion and wage levels. They are by no means the only offenders. Many other corporations can rival them.

But in our view, the "Dirty Dozen" are particularly outstanding as poor corporate citizens, in terms of one or more of the following criteria: Lobbying or strong public advocacy for amnesty and increased legal immigration, liaison with groups working against immigration law enforcement such as the National Council of La Raza, a reputation for hiring legal and illegal immigrants to the exclusion of Americans.

1) **Allstate**. This insurance company has lobbied the House to pass legislation with provisions similar to the Senate's 2013 "reform" legislation which would sharply increase legal immigration and increase the number of visas for temporary foreign workers. This demand is based on the bogus claim that the U.S. faces a "labor shortage." Currently, 20 million Americans cannot find full-time employment. It also has supported the National Council of La Raza and the anti-enforcement Mexican American Legal Defense and Educational Fund (MALDEF).

2) **Bank of America**. This institution has issued credit cards to people without Social Security numbers, knowing full well that virtually everyone in this category is an illegal alien. Bank of America has supported the National Council of La Raza, the anti-enforcement League of United Latin American Citizens (LULAC) and MALDEF.

3) **Coca Cola**. This corporation has lobbied the House to pass legislation with provisions similar to the Senate's 2013 "reform" legislation which would sharply increase legal immigration and increase the number of visas for temporary foreign workers. Coca Cola has supported LULAC and MALDEF.

4) **Facebook**. This corporation strongly supports passage of legislation similar to the Senate's bill. Its CEO, Mark Zuckerberg, has become a leading advocate of amnesty for illegal aliens as well as increasing legal foreign workers. He has organized a nationwide advertising campaign to promote this agenda.

5) **First Data**. This corporation expresses strong support for the Senate's amnesty/mass immigration bill. It created a \$10 million "empowerment fund" to promote radical Hispanic groups and pro-immigration activism. This corporation, significantly through its subsidiary Western Union, profits from illegal aliens wiring money back to their home countries. Western Union assists LULAC.

6) **Intel**. This firm has lobbied the House to pass legislation with provisions similar to the Senate's 2013 "reform" legislation which would sharply increase legal immigration and

increase the number of visas for temporary foreign workers. Intel claims there is a shortage of American high-tech workers, though much data suggest otherwise.

7) **McDonald's**. This fast-food company has lobbied the House to pass legislation with provisions similar to the Senate's 2013 "reform" legislation which would sharply increase legal immigration and increase the number of visas for temporary foreign workers. While seeking to bring in more foreign workers, McDonald's is known for the low wages it pays its U.S. work force. McDonald's assists the National Council of La Raza and LULAC.

8) **Microsoft**. This computer software company firm has lobbied the House to pass legislation with provisions similar to the Senate's 2013 "reform" legislation which would sharply increase legal immigration and increase the number of visas for temporary foreign workers. Microsoft's CEO Bill Gates is a vocal proponent of the claim that there is a shortage of American high-tech workers.

9) **State Farm**. This insurance company has lobbied the House to pass legislation with provisions similar to the Senate's 2013 "reform" legislation which would sharply increase legal immigration and increase the number of visas for temporary foreign workers. State Farm is a strong supporter of the National Council of La Raza, having sponsored a number of its annual national conferences.

10) **Tyson's Foods**. This food conglomerate is notorious for massive large-scale hiring of foreign-born workers. Many have charged that Tyson's Foods has deliberately hired illegal aliens. The company has been acquitted of these changes in court, though two of its lower-level managers offered plea bargains. More recently the company has focused on hiring refugees and other legal immigrants, despite high U.S. unemployment. The company contributes to the resettlement of refugees in the U.S. Tyson's Foods supports amnesty and the basic provisions of the Senate's "reform" legislation. It assists LULAC.

11) **UPS**. This delivery company has lobbied the House to pass legislation with provisions similar to the Senate's 2013 "reform" legislation which would sharply increase legal immigration and increase the number of visas for temporary foreign workers. UPS supports the National Council of La Raza.

12) **Walmart**. This corporation supports all of the Senate's amnesty/mass immigration legislation, which would enable more foreign workers to take American jobs. Walmart is known for the low wages it pays its U.S. work force. The Walmart Foundation has supported the National Council of La Raza and LULAC.
